### TERMS & CONDITIONS

Raffle is free of charge.
3. **DRAWING:** Registering closes on Wednesday, December 6th and on Thursday, December 7th winners will be randomly drawn.
4. **PRIZE:** Each confirmed winner will have the exclusive right to buy one pair from 36 raffled Air Jordan 1 „Banned” (2016 release) in pre-selected size for the price of 160 €. Winners will be informed through e-mail.
5. **OBLIGATIONS:** If your entry will be drawn then you have 72 hours to follow the instructions from the e-mail message and to complete the purchase. If the prize won’t get picked up by then, another winner will be drawn from the registered entries. Winner may not substitute the prize with another product. You have the right to access your personal data and revise it if needed. You may also cancel your subscription at any time.
9. **DISPUTES:** You agree that any disputes, claims and causes of action arising out of, or connected with the Raffle or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in Olsztyn, Poland.
